Across five focused days, you will work through the major frameworks of corporate and competitive strategy alongside the disciplines specific to family enterprises — the three-circle model, the family constitution, succession planning, governance design, and the long-horizon capital allocation that family businesses can do better than anyone. The programme is delivered by senior practitioners with executive and family-business experience.

- Apply mainstream strategy frameworks — Porter, PESTLE, the resource-based view — to a family-controlled business.
- Diagnose the family-business system using the three-circle model.
- Distinguish the strategic time horizon of a family business from that of a listed company.
- Lead a portfolio review across multiple generations of owner expectation.
- Design and govern long-horizon capital allocation as a family enterprise.
- Build a credible succession strategy across ownership, governance and management.
- Draft or strengthen a family constitution and the related governance bodies.
- Communicate strategy to family, board and non-family executives in a single coherent story.
- Identify the strategic risks specific to family-controlled enterprises.
