Financial Modeling for Decision Makers is a 5-day senior-level financial modelling course delivered by Mars Training Centre UK in Europe, the Gulf and North America — London, New York, Dubai, Amsterdam and Istanbul — designed for finance directors, FP&A leaders, corporate development professionals, and senior analysts whose models support real executive decisions.

The financial model is the central artefact of most senior decisions: acquisitions, capital projects, refinancing, restructuring, and the annual plan. The quality of the model determines the quality of the decision. Yet many models in use today are fragile, opaque, and indefensible under stress. The leaders whose models are clean, transparent, and properly stress-tested make sharper decisions and lose far less time to rework.

Across five focused days, you will work through model design principles, the integrated three-statement model, valuation models, scenario and sensitivity analysis, and the practice that separates a robust model from a fragile one. The cases are drawn from corporate transactions in the United Kingdom, Europe, and the Middle East, and the work is delivered by senior practitioners with modelling experience in corporate finance.

What You Will Learn

- Design financial models using disciplined and auditable structures.
- Build a fully integrated three-statement model from a blank workbook.
- Apply best-practice formatting, naming, and version-control conventions.
- Build robust scenario, sensitivity, and break-even analyses.
- Construct a discounted cash flow valuation model.
- Build a leveraged buyout and an accretion-dilution model.
- Stress-test models for downside cases and structural breaks.
- Identify and remediate common model errors and fragilities.
- Communicate model outputs to non-finance executives.
- Lead a financial modelling project from brief to decision.
