International Trade and Incoterms 2020 is a five-day international trade and Incoterms course delivered by Mars Training Centre internationally — in London, Amsterdam, Dubai, Istanbul, and Jakarta — designed for trade, logistics, procurement, and commercial leaders responsible for cross-border movement of goods.

Cross-border trade has become more demanding, not less. Tariff regimes are shifting, sanctions screening has become a daily reality, customs requirements have multiplied since Brexit, and the discipline around shipping documents, payment terms, and risk transfer has tightened. The Incoterms framework — the International Chamber of Commerce's published trade-terms rules — sits at the heart of how risk, cost, and obligation are allocated in every international sale of goods, and senior trade and supply chain leaders need a fluent command of how to apply the 2020 edition in practice.

Across five focused days, you will work through international trade as an integrated discipline — Incoterms 2020, customs and tariffs, documentary credit and payment, sanctions and compliance, and the operational disciplines that keep cross-border flows moving. You leave with a personal action plan grounded in your own trade flows and counterparty profile.

Mars references Incoterms 2020 descriptively, as the International Chamber of Commerce's published trade-terms framework. This course does not carry ICC accreditation; we teach the practical application of the rules.

- Apply each of the eleven Incoterms 2020 rules correctly in commercial agreements.
- Allocate risk, cost, and obligation between buyer and seller under each rule.
- Select the appropriate Incoterm for a given trade flow and mode.

- Apply the basics of customs classification, valuation, and origin.
- Understand documentary credits, payment terms, and trade finance instruments.
- Apply sanctions, export controls, and trade compliance frameworks.
- Manage marine cargo insurance for international shipments.
- Resolve common disputes arising from misapplied trade terms.
- Build internal trade procedures aligned with Incoterms 2020.
