Artificial Intelligence for Executives is a 5-day senior-leader course delivered by Mars Training Centre UK at our international training centres — in London, Dubai, Amsterdam, New York, and Tokyo — designed for directors, vice presidents, and general managers who need to govern, fund, and lead the use of AI in their organisations.

Boards and executive teams are now expected to make sound decisions about artificial intelligence: what to deploy, what to refuse, what to invest in, and what to govern. The week moves from executive foundations and AI economics, through strategy and value cases, into governance, risk and ethics, then the people and operating-model work of an AI-enabled organisation, closing with a personal 12-month roadmap.

- Distinguish between machine learning, generative AI, agentic AI, and traditional automation in business terms.
- Evaluate AI investment proposals using a structured commercial and risk lens.
- Identify the use cases in your organisation where AI is most likely to create value.
- Apply a governance framework for AI risk, ethics, and accountability at board level.
- Interrogate AI vendors and internal teams with the right executive-level questions.
- Lead the cultural and workforce implications of deploying AI in your organisation.
- Assess the international regulatory landscape for AI, including the UK, EU, and Gulf positions.
- Design a 12-month AI roadmap aligned to your business strategy.

You will leave with the executive vocabulary, decision frameworks, and governance instincts to lead AI conversations with confidence, and a Mars Certificate of Completion.

Your organisation will gain a senior leader who can challenge AI proposals on commercial merit, govern AI risk responsibly, prioritise the right use cases, and avoid the costly mistakes that come from delegating these decisions entirely to technical teams.
