Across five days, you will work through frameworks for decision quality, examine how cognitive biases play out at executive level, and practise on real cases including scenarios drawn from financial services, energy, and the public sector.

- Apply structured frameworks for decisions under uncertainty.
- Identify the cognitive biases most likely to degrade your own decisions.
- Distinguish decision quality from outcome quality and use both correctly.
- Lead group decisions without falling into groupthink or false consensus.
- Use data, analytics, and judgement together rather than in opposition.
- Make and communicate reversible and irreversible decisions appropriately.
- Decide under time pressure without sacrificing rigour.
- Build a personal decision-discipline practice for the 90 days after the course.
