AI for HR and People Analytics is a 5-day senior leadership course delivered by Mars Training Centre UK across Europe, the Gulf, Africa, and Asia — in London, Dubai, Amsterdam, Cairo, and Kuala Lumpur — designed for HR directors, chief people officers, and senior business leaders who own the use of AI and analytics in people decisions.

AI is now embedded across the people lifecycle: candidate sourcing and screening, internal mobility, learning recommendations, workforce planning, sentiment analysis, and pay-equity diagnostics. The opportunities are real and the risks are serious — for fairness, for legal exposure, and for the trust of the workforce. This programme is built for the senior leader who must lead that work, not the technical practitioner who builds the models.

The week moves from AI and analytics in the people function, through talent acquisition, mobility and learning, into fairness, bias and legal risk, then governing people data and the function itself, closing with a personal action plan.

- Distinguish people analytics, predictive HR, and generative AI in HR contexts.
- Evaluate AI vendors and HR-tech proposals critically.
- Apply a fairness and bias framework to people-decision models.
- Govern people data ethically, lawfully, and transparently.
- Lead the workforce conversation about AI in HR honestly.
- Design a people-analytics operating model fit for your organisation.
- Build a 12-month AI roadmap for the people function.
