- Evaluate enterprise blockchain use cases on commercial merit.
- Assess tokenisation, stablecoins, and CBDC implications for your business.
- Apply a governance and risk framework to blockchain initiatives.
- Navigate the international regulatory picture for digital assets across the UK, EU, and Gulf.
- Identify when blockchain is the right answer — and when a database is.
- Build a 12-month position and roadmap on blockchain for your organisation.

You will leave with the executive vocabulary, judgement, and risk lens to take a defensible position on blockchain and Web3, and a Mars Certificate of Completion.
