Organisations that treat risk as a checklist or a quarterly report no longer survive the shocks the modern environment produces; the ones that integrate risk thinking into strategy, capital allocation and culture do.

This programme builds a senior practitioner's command of enterprise risk management using the leading international frameworks — ISO 31000, COSO ERM, and the principles that sit beneath them — and applies them to the real risk landscape that delegates carry into the classroom. - Communicate risk to the board, the audit committee and the wider executive team.
