Whistleblowing and Internal Investigations is a five-day senior investigations course delivered by Mars Training Centre in London, Paris, Amsterdam, Dubai and Prague — designed for heads of compliance, general counsel, investigations leads and senior HR leaders who run their organisation's whistleblowing and investigations function.

Whistleblowing and internal investigations have become a recognised executive discipline. The UK Public Interest Disclosure Act, the EU Whistleblowing Directive and equivalent legislation in many jurisdictions now protect those who raise concerns and place obligations on employers to handle disclosures lawfully. Boards expect a credible speak-up culture, well-run investigations and findings they can act on. Mishandled cases — whether through retaliation, poor investigation or delayed response — have become a leading source of regulatory and reputational damage.

This programme builds the senior practitioner's command of the whistleblowing channel, the internal investigation and the difficult decisions that surround both. It is delivered by senior practitioners drawn from the Mars panel.

- Apply the major whistleblowing legal regimes — UK, EU and equivalent — to your channel design.
- Build a whistleblowing programme that earns the trust of employees and the board.

- Conduct fact-finding and subject interviews credibly and lawfully.
- Manage evidence and confidentiality through the investigation lifecycle.
- Report investigation outcomes to the board, regulators and external authorities.
- Design anti-retaliation safeguards and protect those who raise concerns.
