The difference between a profitable asset and a stranded one increasingly comes down to the quality of senior management — how it reads margins, plans turnarounds, integrates with petrochemicals, and positions the asset for the next twenty years.

This programme equips senior refining and downstream leaders with the structured commercial, operational, and strategic frameworks needed to lead a refining business through the current decade. You will examine refinery configurations, margin formation, planning and scheduling discipline, turnaround economics, and the strategic questions facing every refining executive: integration with petrochemicals, low-carbon products, and asset longevity.

- Describe the principal refinery configurations and their commercial implications.
- Analyse refinery margin formation and the levers a manager can pull.
- Evaluate the planning and scheduling discipline that drives refinery profitability.
- Assess crude selection decisions and their impact on yields and constraints.
- Apply turnaround and major maintenance economics at executive level.
- Diagnose the principal HSE and process-safety risks in refining operations.
- Evaluate refining-petrochemical integration strategies and their commercial logic.
- Position a refining asset against energy-transition scenarios and low-carbon product demand.
- Read a refinery's operational and financial performance with executive judgement.
- Lead a senior refinery management team with clear commercial direction.
