LNG has moved from a niche regional business to one of the most strategic commodities in the energy mix. Europe's pivot away from pipeline gas, the rapid build-out of Gulf Coast liquefaction, major Middle Eastern expansions, and emerging Asian demand have reshaped global gas in less than a decade. Long-term contract structures, pricing references, shipping economics, and regulatory regimes are all in motion at once — and senior decision-makers in operators, buyers, traders, ministries, and lenders need a confident command of how the market actually works.

This programme builds that command. Across five days you will trace LNG from liquefaction through shipping, regasification, and end-market — examining contract structures, pricing mechanisms, trading dynamics, and the geopolitical forces moving the market. The focus is commercial and strategic, not engineering.

- Analyse the principal LNG contract structures and pricing formulas.
- Evaluate liquefaction, shipping, and regasification economics.
- Interpret the relationship between oil-linked, hub-based, and spot LNG pricing.
- Assess the credit and counterparty risks in long-term LNG transactions.
- Diagnose the geopolitical drivers reshaping global gas flows.
- Apply scenario thinking to LNG supply-demand and price outlooks.
- Compare the strategic positions of major exporters and importers.
- Evaluate the role of LNG in the energy transition and as a transitional fuel.
- Communicate LNG market dynamics confidently to boards and ministries.
