- Diagnose the principal commercial risks in renewable energy projects.
- Evaluate the role of carbon pricing, border adjustment, and disclosure regimes.
- Position your organisation against the transition pathways most likely to unfold.
- Compare the strategic responses of oil majors, utilities, and national oil companies.
- Lead a senior team through transition strategy and execution.
