The discipline of operating pipelines safely, reliably, and commercially is one of the most underappreciated leadership challenges in the energy sector — and one of the most consequential when it fails.

This programme equips senior pipeline and midstream leaders with the structured operational, commercial, and strategic frameworks needed to run pipeline assets at executive level. You will cover pipeline systems and hydraulics at a senior literacy level, integrity management discipline, operational control rooms, regulatory frameworks, and the strategic positioning of pipeline assets in a system being reshaped by renewables and new fuels.

- Assess control room operations, SCADA, and leak detection at senior level.
- Interpret pipeline tariff structures and commercial arrangements.
- Evaluate the regulatory frameworks governing pipeline operations.
- Lead a pipeline operations and integrity team with discipline.
- Position pipeline assets for life extension, repurposing, or retirement.
